WCK began receiving calls for aid from all over the island and began to expand operations all across the island, mobilizing a network of emergency kitchens, food trucks, and partner organizations to make sure that communities in need received quality meals. The #ChefsForPuertoRico movement quickly grew to serve over 150,000 meals in a single day to communities all across the island, becoming the largest fresh meal operation following the hurricane. #ChefsForPuertoRico continues to remain active by empowering our chef and food truck partners through rebuilding**
